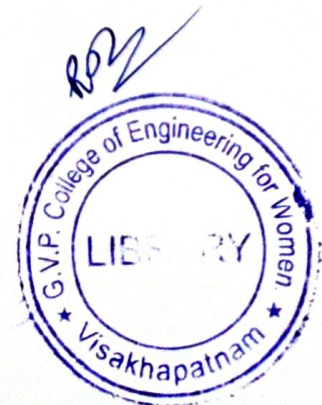

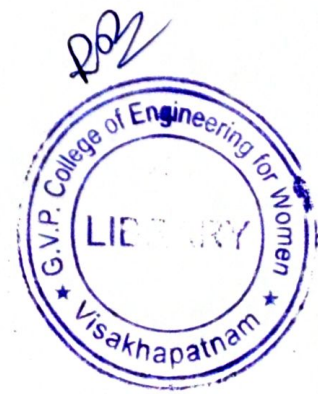
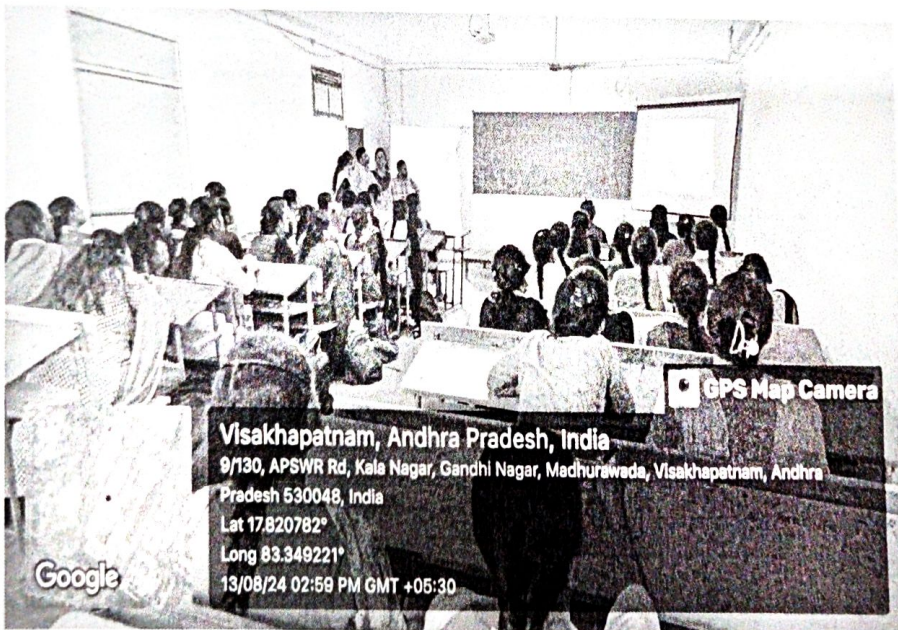
Library Orientation Programme for 1<sup>st</sup> year ECE students

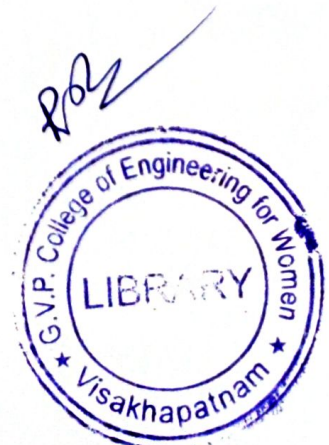

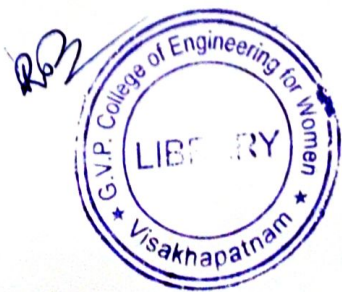
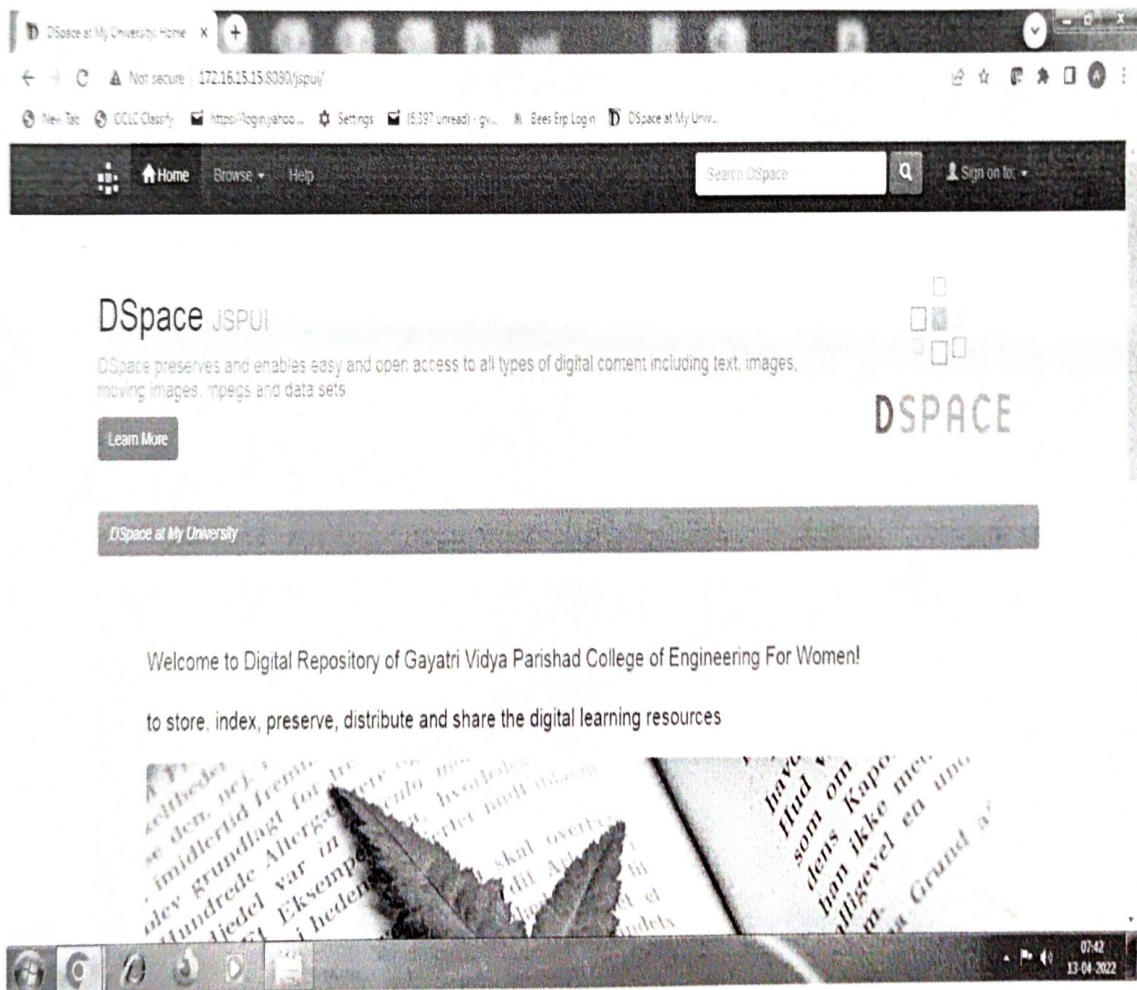
